Dear Ms. Hagan:

On December 4, 2018, the Commission on State Mandates (Commission) received the State Water Resources Control Board's and the San Diego Regional Water Quality Control Board's (Water Boards') request for an extension of time to file comments on the above-named Test Claim and the administrative records on the above-named Order.

Specifically, the Water Boards request a 38-day extension beyond the current due date of December 21, 2018 in order to coordinate efforts to analyze the merits of this Test Claim and develop written comments and also to prepare complete administrative records.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, the Water Boards' comments on the Test Claim and administrative records on the Order are now due **January 28, 2019**. The claimant's rebuttal comments are now due 30 days from the service of the Water Boards' comments and administrative records.

In addition to other matters pending before the Commission, this matter's tentative hearing date has been updated. This matter is now tentatively set for **March 26, 2021**.


