On March 13, 2019, the Commission on State Mandates (Commission) received the City of Rialto's request for an extension of time to file rebuttal comments to the Department of Finance's (Finance's) Late Comments on the above-named Test Claims, currently due on April 8, 2019.

Specifically, the City of Rialto requests to file rebuttal comments to both Finance's Late Comments on the Test Claim, served on March 8, 2019, and the Water Boards' comments on the Test Claim and administrative record on the Order, currently due on March 29, 2019, 30 days from the service of the Water Boards' comments and administrative record.

Section 1183.3(a) of the Commission's regulations provide that written rebuttals to written comments concerning a test claim may be filed, and shall be certified, filed, and served in accordance with section 1181.3 of these regulations within 30 days of service of the written comments.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Please be reminded that these Test Claims have not been consolidated, but are being addressed in this single approval letter for the sake of efficiency. The decision on whether to consolidate any or all of these matters for hearing will be made by the executive director once comments have been submitted and the records are thoroughly reviewed for analysis and hearing. Though there are likely some cross-cutting issues, it is not possible to determine the appropriateness of the proposed consolidation for purposes of the Commission's analysis and hearing, until the parties' legal arguments and any relevant evidence applicable to each Test Claim has been filed.
