On April 17, 2020 the Department of Finance (Finance) filed a request with the Commission on State Mandates (Commission) for a 60-day extension of time to file comments on the above-captioned Test Claim, currently due April 20, 2020.

Specifically, Finance requests an extension of time to June 19, 2020 due to additional workload and logistical challenges with protective measures, such as teleworking, associated with the COVID-19 pandemic, making it not possible to review and respond to the claimant's Test Claim by the original deadline.
