Dear Ms. Kurokawa:

On September 20, 2021, the Commission on State Mandates (Commission) received the State Controller's Office's (Controller's) request for a 30-day extension of time to file written comments and supporting documentation on the above-captioned Incorrect Reduction Claim (IRC), currently due on September 22, 2021.

Specifically, the request states that the Controller requires an extension of time due to delays and reprioritizations due to the COVID-19 crisis in order to adequately address the concerns of the claimant, City of South Lake Tahoe.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

However, Government Code section 17553(d) provides, in part that "the Controller shall have no more than 90 days after the date the claim is delivered or mailed to file any rebuttal to an IRC. The failure of the Controller to file a rebuttal to an IRC shall not serve to delay the consideration of the IRC by the Commission."

Commission staff finds the request states good cause. Therefore, a 30-day extension from the original due date is approved for good cause shown and the Controller's comments are now due **by 5:00 p.m. October 22, 2021.**

However, the Commission has not been granted any reprieve from timely performing its duties due to the operational impacts of COVID-19 and therefore will not delay its analysis of the claim. If the Controller is unable to file comments prior to a draft proposed decision being issued for this matter, it will have an opportunity to file its comments on the draft proposed decision.

This matter remains tentatively set for hearing on **September 23, 2022.**
