Dear Ms. Calvert:

On January 10, 2023, the Commission on State Mandates (Commission) received the Department of Finance's (Finance's) request for a 60-day extension of time to file written comments on the above-captioned Test Claim, currently due on January 13, 2023.

Specifically, Finance's request states that an extension of time to March 14, 2023 is necessary because of the length of the Test Claim which raises numerous, complex issues. In addition, the request states that due to work associated with preparing the 2023-2024 Governor's Budget for release by its statutory deadline of January 10, 2023, staff will be unable to review and respond to the Test Claim by March 14, 2023.

Section 1187.9(a) of the Commission's regulations provide that any party or interested party to a matter may request an extension of time by filing a request with the executive director before the date set for filing of comments or rebuttals with Commission staff on that matter. The request shall fully explain the reasons for the extension, propose a new date for filing, and be certified, filed, and served in accordance with section 1181.3 of these regulations. A request that would necessitate rescheduling a hearing shall also include a request for postponement of the hearing, pursuant to subdivision (b) of this section.

Therefore, a 60-day extension from the original due date is approved for Finance and their comments on the Test Claim are now due **by 5:00 p.m. on March 14, 2023**. This matter remains tentatively scheduled for hearing on Friday, **December 1, 2023**.


