Dear Ms. Calvert and Ms. Nuñez:

On July 7, 2023, the Commission on State Mandates (Commission) received the State Water Resources Control Board's and the Los Angeles Regional Water Quality Control Board's (collectively, "the Water Boards") request, and on July 10, 2023, received the Department of Finance's (Finance's) request, for a 45-day extension of time to file written comments on the above-captioned Test Claim, currently due on July 14, 2023.

Specifically, the Water Boards state that an extension of time to August 28, 2023 is necessary because the Test Claim raises numerous and complex issues and is over 2,000 pages long, including attachments; due to the complexity and length of the Test Claim, considerable staff and attorney time is needed to analyze the merits of the Test Claim, research and provide comments; staff responsible for responding to the Test Claim have a number of other priority duties that limit their ability to work exclusively on this matter; there have been significant staffing changes at the Water Boards, including the hiring of the Los Angeles Water Board's new Executive Officer who started on May 2, 2023; and one of the attorneys previously assigned to work on matters related to the Los Angeles Water Board's MS4 permit has been rotated to another region as of July 1, 2023 and is no longer available to assist in this matter. Further, the request states that the Water Boards are not aware of any prejudice to any party or interested person or any other good reason that the request for more time should not be granted. Finally, the request states that the Water Boards respectfully ask for approval of this request for extension of the deadline to submit written comments to August 28, 2023.

In addition, Finance's request states that a 45-day extension of time to 5:00 p.m. on August 28, 2023, is required due to the length of the Test Claim, which raises numerous complex issues, as well as staff work associated with state budget enactment, staff will be unable to review and respond to the Test Claim by July 14, 2023.

Section 1187.9(a) of the Commission's regulations provide that any party or interested party to a matter may request an extension of time by filing a request with the executive director before the date set for filing of comments or rebuttals with Commission staff on that matter. The request shall fully explain the reasons for the extension, propose a new date for filing, and be certified, filed, and served in accordance with section 1181.3 of these regulations. A party to a matter may request an extension of time that would necessitate rescheduling the hearing, but shall also include a request for postponement of the hearing, pursuant to subdivision (b) of this section. (Cal. Code. Regs., tit. 2 § 1187.9(a).)

A 60-day extension from the original due date is approved for the Water Boards and Finance and their comments on the Test Claim are now due **by 5:00 p.m. on September 12, 2023**. If the parties are in fact able to file their comments within 45 days, as requested, they are encouraged to do so. This matter remains tentatively scheduled for hearing on **Friday, January 24, 2024**.
