Dear Ms. Nuñez:

On October 28, 2022, the Commission on State Mandates (Commission) received the State Water Resources Control Board's and the Los Angeles Regional Water Quality Control Board's (collectively, "the Water Boards") request for a 91-day extension of time to file written comments on the above-captioned Test Claim, currently due on November 14, 2022.

Specifically, the Water Boards' request states that an extension of time to February 13, 2023 is necessary because the Test Claim raises numerous and complex issues and is over 2,000 pages long, including attachments. In addition, the request states that given the complexity and length of the Test Claim, analyzing the merits will require considerable staff and attorney time to research and provide comments. Further, the request states that staff are responsible for other priority duties that limit their ability to work exclusively on this matter, including work in preparing orders for consideration by the Water Boards at their monthly meetings and working with the Attorney General's Office on existing litigation matters. Finally, the request states that staff and attorneys involved in the preparation of comments have pre-planned vacations during the upcoming winter holidays.

Section 1187.9(a) of the Commission's regulations provide that any party or interested party to a matter may request an extension of time by filing a request with the executive director before the date set for filing of comments or rebuttals with Commission staff on that matter. The request shall fully explain the reasons for the extension, propose a new date for filing, and be certified, filed, and served in accordance with section 1181.3 of these regulations. A request that would necessitate rescheduling a hearing shall also include a request for postponement of the hearing, pursuant to subdivision (b) of this section.

Although this request would not currently require postponement of the hearing on the matter, the claimant will also have a 30-day rebuttal period following the filing of the comments and may also seek an extension of time for good cause. Given the established 30-day comment period and the duty of the executive director to expedite matters before the Commission, a 91-day extension of time cannot be granted and extensions are, as a matter of practice, limited to no more than 60 days. Therefore, a 60-day extension from the original due date is approved for the Water Boards and their comments on the Test Claim are now due **by 5:00 p.m. on January 13, 2022.**

This matter remains tentatively set for hearing on Friday, **September 22, 2023.**
