REQUEST FOR 30-DAY EXTENSION OF TIME TO SUBMIT COMMENTS

Dear Ms. Halsey:

By letter dated October 14, 2022, the Commission on State Mandates (Commission) issued a Notice of Complete Joint Test Claim, Schedule for Comments, and Notice of Tentative Hearing Date for the above Test Claim. On May 10, 2024 the State Water Resources Control Board and the California Regional Water Quality Control Board Los Angeles Region (collectively, Water Boards) previously sought and obtained an extension to submit comments as well as a postponement of the hearing for this matter. The hearing is tentatively scheduled for December 5, 2025.


On July 11, 2024, the Parties in this matter stipulated to a deadline extension for the Water Boards to submit its comment “by no later than 45 days after the hearing on the 2012 Test Claim or January 6, 2025, whichever is earlier.” The Parties have revised their stipulation to remove the January 6, 2025 deadline and the new stipulated deadline is “45 days after the hearing on the 2012 Test Claim.” The revised stipulation is attached.

COMMISSION ON STATE MANDATES - TEST CLAIM NO. 22-TC-01


STIPULATION TO EXTEND TIME FOR WATER BOARDS TO SUBMIT COMMENTS ON TEST CLAIM AND TO POSTPONE HEARING

1. By letter dated October 14, 2022, the Commission on State Mandates ("Commission") issued a Notice of Complete Joint Test Claim, Schedule for Comments, and Notice of Tentative Hearing Date for Test Claim No. 22-TC-01 ("2022 Test Claim") for Regional Water Quality Control Board, Los Angeles Region ("Regional Board") Order No. R4-2021-0105.
2. The parties to the 2022 Test Claim are the County of Los Angeles, the Los Angeles County Flood Control District, the Department of Finance, the Regional Board, and the State Water Resources Control Board ("State Water Board"; collectively, "the Parties").
3. In a letter dated May 10, 2024 to Heather Halsey, Executive Director of the Commission, the Regional Board and the State Water Board (collectively, "the Water Boards") requested the following:
 - 3.1. A 60-day extension to file written comments on the 2022 Test Claim (from May 13, 2024 to July 12, 2024); and
 - 3.2. A postponement of the hearing on the 2022 Test Claim until the Commission's next regularly scheduled meeting, tentatively scheduled for March 28, 2025.
4. On May 13, 2024, the Commission granted the Water Boards' request for an extension of time. The Commission set the Water Boards deadline to submit comments on the 2022 Test Claim as July 12, 2024 and tentatively scheduled the 2022 Test Claim for hearing on March 28, 2025.
5. Regional Board Order No. R4-2021-0105 is similar in some respects to Regional Board Order No. R4-2012-0175, which is subject to consolidated Test Claims Nos. 13 TC-01 and 13-TC-02 ("the 2012 Test Claims"). The 2012 Test Claims are tentatively scheduled for hearing on March 28, 2025.
6. Given the similarities between Regional Board Orders No. R4-2021-0105 and No. R4-2012-0175, the resolution of the 2012 Test Claim is expected to reduce the number of issues in the 2022 Test Claim, thereby facilitating comments on the 2022 Test Claim and the associated draft proposed decision.
7. The Water Boards have also indicated that they are experiencing resource constraints, including ongoing staffing shortages in the State Water Board Office of Chief Counsel.
8. On July 11, 2024, the Parties stipulated to an extension of time for the Water Boards to submit their comments on the 2022 Test Claim by no later than 45 days after the hearing on the 2012 Test Claim or January 6, 2025, whichever is earlier.

9. Pursuant to Commission regulations, an extension of time can be no more than 60 days; however, the Parties may stipulate to a longer time frame.
10. As of November 22, 2024, the Commission has 37 pending test claims. The 2022 Test Claim is tentatively scheduled for December 05, 2025.
11. In light of all of the above, the Parties stipulate to extend the deadline for the Water Boards to submit comments on the 2022 Test Claim to 45 days after the hearing on the 2012 Test Claim.


