Dear Ms. Sablan:

On September 6, 2024, the Commission on State Mandates (Commission) received the State Water Resources Control Board's and the San Francisco Bay Regional Water Quality Control Board's (collectively, "the Water Boards") request for a 60-day extension of time to file written comments on the above-captioned Test Claim, currently due on September 16, 2024.

Specifically, the Water Boards' request states that a 60-day extension of time to November 15, 2024, is necessary because: the Test Claim raises many complex issues and is over 2,000 pages long, including attachments; given the complexity and length, analyzing the merits of the Test Claim will require considerable staff and attorney time to review, research the issues, and draft comments; since the attorney assigned to this matter did not work on San Francisco Bay Water Board Order No. R2-2-2022-0018 on which the Test Claim is based, or its previous iterations, additional time is needed to become familiar with the requirements.

Further, the request states that after the Water Boards submitted its first extension request for this matter on July 8, 2024, the Commission issued the Draft Proposed Decision for *California Regional Water Quality Control Board, San Francisco Bay Region, Order No. R2-2009-0074, 10-TC-02, 10-TC-03, and 10-TC-05* with comments due on October 28, 2024, and the Water Boards do not have the resources to simultaneously work on both comments and are prioritizing the comments on the Draft Proposed Decision.

The request also states that Water Boards' staff are responsible for other priority duties that limit their ability to work exclusively on Commission matters, including preparation for monthly board meetings, significant permitting and cleanup matters, and other pressing water quality matters that impact public health and the environment; and staff and attorney time is further limited by previously planned vacations in September.



Finally, the request states that extending the deadline for comments on the Test Claim will provide the Water Boards with the necessary time to prepare comments and will not require postponement of the tentatively scheduled May 23, 2025 hearing, and the Water Boards are not aware of any prejudice to any party or interested person or any other good reason that the request for more time should not be granted.

Section 1187.9(a) of the Commission's regulations provide that any party or interested party to a matter may request an extension of time by filing a request with the executive director before the date set for filing of comments or rebuttals with Commission staff on that matter. The request shall fully explain the reasons for the extension, propose a new date for filing, and be certified, filed, and served in accordance with section 1181.3 of these regulations. A request that would necessitate rescheduling a hearing shall also include a request for postponement of the hearing, pursuant to subdivision (b) of this section.

Therefore, a 60-day extension from the original due date is approved and the Water Boards' comments on the Test Claim are now due **by 5:00 p.m. on November 15, 2024**. This matter remains tentatively scheduled for hearing on **Friday, May 23, 2025**.
