Dear Ms. Ameer and Ms. Chinn:

On July 27, 2018, the Commission on State Mandates (Commission) received the claimant's request for extension of time to submit written comments in response to the Draft Proposed Decision issued July 20, 2018, on above-captioned Test Claim.

Specifically, the request states that the claimant requires a three-week extension beyond the current deadline of August 10, 2018 to August 31, 2018, due to the vacation of the claimant's lead representatives who are scheduled to return on August 6, 2018.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Here, with a three-week extension beyond the current deadline, comments would not be received by the Commission with sufficient time for analysis in advance of the currently scheduled hearing date.

Therefore, comments from the claimant on the Draft Proposed Decision are now due on **August 24, 2017**. This matter remains set for hearing on **September 28, 2018**.

Please note that any further extension requests will also require a request for postponement to the next regularly scheduled hearing.


