Dear Ms. Patton:

We are writing on behalf of the City of Brisbane and the County of San Mateo, the San Mateo County Flood Control District, the Cities of Belmont, Burlingame, Daly City, East Palo Alto, Foster City, Half Moon Bay, Menlo Park, Millbrae, Pacifica, Redwood City, San Bruno, San Carlos, San Mateo and South San Francisco, and the Towns of Atherton, Colma, Hillsborough, Portola Valley and Woodside (Test Claim No. 10-TG-01), and the City of Alameda and the County of Alameda, the Cities of Albany, Berkeley, Dublin, Emeryville, Fremont, Hayward, Livermore, Newark, Oakland, Pleasanton, San Leandro and Union City, the Alameda County Flood Control and Water Conservation District, and the Alameda County Flood Control and Water Conservation, Zone 7 (Test Claim No. 10-TG-02) (hereinafter the "Claimants") to respectfully express Claimants' concern with the extended amount of time it is taking for their test claims to be resolved.


Under Government Code section 17553, Subdivision (a)(2), the Commission is required to implement procedures that ensure a statewide cost estimate is adopted within 12 months of receipt of a test claim, or within 18 months at the request of the claimant or the commission. When you and I briefly spoke on October 13, 2011, you informed me that a decision on Test Claim Nos. 10-TG-01 and 10-TG-02 would not likely be rendered until, at the earliest, the beginning of 2013. You explained that this delay was attributable to the significant backlog of previously-filed test claims and the Commission's intention to wait until litigation regarding other storm water test claims is concluded.

Claimants understand that the Commission, like nearly all public entities, including Claimants, faces budget, staff and other resource constraints, and they also understand the Commission's desire to find out how the courts rule before proceeding with Claimants' test claims. We nevertheless note that these circumstances are not recognized as reasons to extend the time for processing test claims under the applicable statutes. Claimants are continually harmed every month that resources are diverted from other critical programs to

pay for the unfunded mandates at issue in the test claims. Claimants' budget constraints are exacerbated by these delays. Therefore, Claimants respectfully request that their test claims be given priority when the Commission decides to move forward with them.




