Dear Ms. Halsey:

This firm is the designated representative of the Grossmont Union High School District ("District") in this matter.

We formally request an extension to file responsive comments, pursuant to 2 CCR 1187.9(a), and resulting postponement of the hearing. The District, on September 4, 2019 at 2:55 p.m., received the Controller's Comments on the Draft Proposed Decision, along with the Draft Proposed Decision and remainder of the packet in this matter. The District currently has the opportunity to file responsive comments only by September 18, 2019. The Proposed Decision is to be issued on November 8, 2019, and the hearing to be held on November 22, 2019.

The District requests an extension of time to file its comments from September 18th to October 18, 2019, with a resulting postponement of the hearing. The "good cause" reasons for the request for extension of time and postponement include the necessity to fully address key issues within 1) the voluminous record consisting of nine (9) volumes; 2) the detailed State Executive Summary of the Draft Proposed Decision consisting of 15 pages; 3) the lengthy Draft Decision itself consisting of 57

pages, plus numerous exhibits including the IRC as Exhibit D; and 4) the Controller's Office Late Comments, and accompanying material, dated September 13, 2017 consisting of 128 pages, plus exhibits. Counsel is also involved with other litigation whose dates conflict with the current deadlines. These grounds meet the 2 CCR 1187.9(b)(6) and 2(A) and (B) for postponement.

This extension will allow the District to fully respond to the Draft Decision and the positions of the Controller to assist the Commission in reaching a final Decision. The requested extensions will prejudice no party, or other interested party.


