Dear Ms. Chinn:

On September 7 2018, the Commission on State Mandates (Commission) received the claimant's request for time to submit written comments to respond to the State Controller's Office (Controller's) late comments filed August 31, 2018 and for postponement of the September 28, 2018 hearing on the above-captioned Incorrect Reduction Claim.

Section 1187.9(a) of the Commission's regulations provides that a party to a matter may request an extension of time that would necessitate rescheduling a hearing, but shall also include a request for postponement of the hearing, pursuant to section 1187.9(b). (Cal. Code. Regs., tit. 2 § 1187.9(a).)

Section 1187.9(b) of the Commission's regulations provides that each request for postponement will be considered on its own merits and must fully explain the reasons for the request. While postponements are disfavored and pursuant to Government Code section 17530, the executive director has a duty to expedite all matters before the Commission, a request for postponement may be approved for good cause. (Cal. Code. Regs., tit. 2 § 1187.9(b).)



Section 1187.9(b)(1)(A) of the Commission's regulations provides that the circumstances that may indicate good cause include the unavailability of a party, party representative, or witness because of death, illness, or other excusable circumstances. (Cal. Code. Regs., tit. 2 § 1187.9(b)(1)(A).)

Specifically, the request states that the claimant requires a three-week extension to October 1, 2018, due to the need for additional time to gather information to respond to the Controller's late comments, having to travel to meet with clients to prepare for the next state mandate claiming deadline, and other work priorities that require time and attention.

Therefore, the request for time to comment and postponement of hearing is approved for good cause as described in section 1187.9(a), (b), and (b)(1)(A) of the Commission's regulations. Claimant's comments are due **October 1, 2018** and this matter is now tentatively set for hearing on **November 30, 2018**.


