On November 16, 2018, the Commission on State Mandates (Commission) received the State Controller's Office's (Controller's) request for a one-month extension of time to file written comments and supporting documentation on the above-captioned Incorrect Reduction Claim.

Specifically, the request states that the Controller requires an extension of time due to competing workload and additional time needed to address the city's issues, currently due on November 21, 2018.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, in the interest of Commission efficiency to avoid the need to process further requests a 60-day extension is approved and the Controller's comments are now due **January 21, 2019**.

In addition to other matters pending before the Commission, this matter's tentative hearing date has been updated. This matter is now tentatively set for hearing on **January 24, 2020**.


