RE: Interested Party County of San Diego’s Request for Second Extension of Time (to August 14, 2020) to Submit Comments on Proposed Decision

Accomplice Liability for Felony Murder, 19-TC-02

Dear Ms. Halsey:

Pursuant to 2 C.C.R. § 1187.9(a), interested party the County of San Diego (the “County”) requests an extension of time to submit comments on the Commission’s proposed decision in the above-referenced test claim. The County requests only a brief extension from August 6, 2020 to **August 14, 2020**.

On July 16, 2020, the County requested an extension of time to August 14, 2020 to submit comments on the proposed decision with the understanding that Claimant LA County was in the process of requesting a postponement of the hearing, which was then tentatively set for September 25, 2020. The County alternatively requested a shorter extension of time to August 6, 2020 if the hearing were not postponed. On July 16, 2020, because the hearing had not been postponed, the Commission granted the County’s request for a shorter extension of time. Subsequently, on July 21, 2020, Claimant requested a postponement of the hearing, which was approved the same day. Accordingly, the hearing is now set for December 4, 2020.


The County therefore requests a second extension of time to August 14, 2020 to submit its comments. This request now will not require a postponement of the hearing set for December 4, 2020. I also am not aware that this request will prejudice any other party or interested party, particularly because the County’s comments will be due on the same date as LA County’s comments.

This request is based on circumstances similar to those that supported the County's earlier request for an extension. Specifically, I am currently managing a heavy caseload, which includes voluminous discovery and two appellate briefs (now due mid-August). I also represent the Registrar of Voters, which is busy preparing for the November election. While I have been working diligently on the County's comments, I request additional time to finalize them in light of my other deadlines.
