Dear Ms. Li:

On December 24, 2018, the Commission on State Mandates (Commission) received the Department of Finance's (Finance's) request for a 60-day extension of time until March 1, 2019 to file comments on four Test Claims filed on Phase I MS4 Trash Orders (17-TC-25 to 17-TC-28).

Previously, on October 22, 2018 and again on December 5, 2018, Finance requested an extension of time to file comments on another Test Claim filed on a Phase I MS4 Trash Order (17-TC-07).

Then on November 20, 2018, Finance requested an extension of time to file comments on 17 additional Test Claims filed on Phase I MS4 Trash Orders (17-TC-08 to 17-TC-24).

In all cases, Finance's request for an extension of time was due to workload related to the preparation of the 2019-2020 Governor's Budget.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

As noted in the notices of complete filing on these matters, the executive director will consider whether to consolidate all or some of these matters for hearing after the comment period is closed. Please include in your comments a discussion of why they should or should not be consolidated, and consider whether there are any differences with regard to the prior law applicable to any of the claimants (including the prior permits) or to any funding sources which could be off-setting or result in a finding under Government Code 17556 and which is not common to all of the claimants in these matters. If such differences do exist between the claimants and their prior permits or revenue sources or authority, that may indicate a need for individual analyses. On the other hand, if all of the issues are shared in common and all claimants stand in the same shoes, consolidation would likely be most efficient.

However, to align the due dates of all 22 Test Claims, a limited extension of 28 days is approved. Therefore, Finance's comments for 17-TC-25, are now due **January 28, 2019**. The claimant's rebuttal comments are now due 30 days from the service of Finance's comments.

This matter remains tentatively set for hearing on **September 22, 2023**.
