On October 18, 2018, the Commission on State Mandates (Commission) received the Department of Finance's (Finance's) request for an extension of time to file comments on the above-named Test Claim.

Therefore, Finance's comments on the Test Claim are now due **December 6, 2018**. The claimants' rebuttal comments are now due 30 days from the service of Finance's comments.

This matter remains tentatively set for **September 25, 2020**.


