Dear Ms. Halsey

By letter dated February 13, 2018, the Commission on State Mandates (Commission) issued a Notice of Complete Joint Test Claim, Schedule for Comments and Notice of Tentative Hearing Date (Notice). The California Regional Water Quality Control Board (San Diego Water Board) and the State Water Resources Control Board (State Water Board) (collectively Water Boards) intend to submit written comments. I am the attorney assigned to test claim matters arising from San Diego Water Board Municipal Separate Storm Sewer System (MS4) permits. In addition to my work on this Test Claim, I am concurrently assisting the Attorney General's Office with four active litigation matters involving the San Diego Water Board with several hearings this month. I also am working concurrently on significant permitting and cleanup matters and numerous extensive California Public Records Act request responses. These competing priorities have limited my ability to devote the time necessary to closely evaluate the Test Claim and complete the Water Boards' comments by the due date of March 15, 2018.


Section 1187.9, subdivision (a) of the Commission's regulations provides that as long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, a request for extension of time to file comments on a test claim shall be approved.

The Notice in this matter tentatively sets the hearing date for September 27, 2019. The Water Boards do not believe that postponement of the hearing will be required if the extension is granted. The Water Boards also believe an extension of time will not prejudice any party and are not aware of any other good cause for denial. Accordingly, for all of the reasons set forth above, the Water Boards request an extension of time of 30 days until **April 16, 2018**. The Water Boards appreciate your consideration of this request.


