Let me go ahead and turn it back over to 4 5 Ms. Dougherty. Thank you, Madam Chair. 6 MS. GMUR: 7 MS. DOUGHERTY: Thank you. Good morning. Item 2 is a test claim alleging new State-mandated 8 activities and costs under Penal Code sections 745 and 9 10 1473 as amended by the Racial Justice Act -- I'm sorry. 11 The Racial Justice For All Act in 2022. 12 In 2020, the Racial Justice Act passed, which 13 banned discrimination in criminal proceedings, but it 14 did so only prospectively for judgments entered on or 15 after January 1st, 2021. The test claim statute made the Racial Justice Act 16 17 retroactive, thereby opening up a petition process for 18 those in state prison and the juvenile justice system. 19 Now anyone who is incarcerated with a judgment 20 entered before January 1st, 2021, may file a petition 21 for writ of habeas corpus to collaterally attack their 22 judgment for racial bias in the prosecution. 23 These claims can go back decades. 24 The purpose of the test claim statute is to erase 25 implicit and explicit racial bias from criminal

judgments entered before January 1st, 2021. It addresses government behavior through the civil proceeding of a habeas corpus petition.

2.

To facilitate these habeas corpus petitions, the act newly requires courts to appoint county public defenders to represent petitioner inmates. This starts when an inmate, by themself, states facts on a habeas corpus petition that would establish a Racial Justice Act violation, or if the state public defender specially requests that the petitioner be represented.

Once appointed, the county public defender must review the petition and amend it if necessary.

Then, if the judge finds that a substantial likelihood of a Racial Justice Act violation exists, the judge schedules an evidentiary hearing. The public defender must represent the habeas petitioner until the conclusion of that hearing.

Commission staff finds the test claim statute imposes a reimbursable State-mandated program within the meaning of Article XIII B, section 6, of the California Constitution and Government Code section 17514; and recommends the Commission approve this test claim and authorize staff to make any technical, nonsubstantive changes to the proposed decision following the hearing.

         The following are the legislative updates since the

1	last time the Commission met:
2	First, AB 964, Commission on State Mandates: State
3	mandates. AB 964 was introduced by Assembly Member
4	Hadwick.
5	This bill amends Government Code section 17558.5.
6	This bill would require the Controller to notify
7	the claimant in writing within 30 days of any adjustment
8	that results from an audit or review; and now requires
9	the Controller to allow a local agency or school
10	district, at the sole discretion of the local agency or
11	school district, to offset any reduced reimbursement as
12	prescribed or to remit funds to the Controller.
13	There has been no new action on this bill.
14	Next, AB 1452, State Mandates: Claims. AB 1452
15	was introduced by Assembly Member Ta.
16	This bill amends Government Code section 17564.
17	This bill would change the minimum claim amount
18	that requires the State to reimburse the local
19	government from \$1,000 to \$800.
20	There has been no new action on this bill.
21	Next, SB 470, Bagley-Keene Open Meeting Act:
22	Teleconferencing.
23	SB 470 was introduced by Senator Laird. This bill
24	now amends Government Code sections 11123.2 and 11123.5.
25	The act authorizes an additional alternative set of
	20

1 provisions under which a state body may hold a meeting 2 by teleconference, subject to specified requirements. 3 Existing law repeals these provisions on January 1st, 2026. This bill now repeals these 4 5 provisions on January 1st, 2030. On September 16th, 2025, this bill was enrolled and 6 7 presented to the governor at 3 p.m. 8 Finally, AB 395, Holidays. AB 395 was introduced by Assembly Member Gabriel. 9 10 This bill amends Government Code section 11131, the 11 Bagley-Keene Open Meeting Act. 12 Among other things, this bill would require that a 13 state agency shall make every reasonable effort to avoid 14 conducting any meeting, conference, or other function on 15 a date for which the state agency knows or has reason to 16 know that members of the public would be unable to 17 participate or be present due to the ritual observance 18 of a religious, cultural, or ancestral holiday, 19 including, but not limited to, Eid al-Adha, Eid al-Fitr, 20 Feast of the Nativity, Maha Shivaratri, the first and 21 last two days of Pesach, also known as Passover, Rosh 22 Hashanah, Yom Kippur, Dawali, and Dussehra. 23 There has been no new action on this bill. 24 Staff will continue to monitor legislation for 25 bills that impact the Mandates process.

1 Thank you. 2 MS. GMUR: Thank you, Jill. 3 Next, Chief Legal Counsel Camille Shelton will 4 present please Item 5, the Chief Legal Counsel Report. MS. SHELTON: Good morning. The Commission is not 5 6 involved in any pending --7 (Court reporter interruption.) MS. SHELTON: I will start over then. 8 9 The Commission is not involved in any pending 10 litigation at this time. So I have nothing to report 11 today. 12 Thank you, Camille. MS. GMUR: 13 And now the Executive Director Report. 14 I have an action item that we're going to begin 15 with, and then two information items thereafter. 16 Our first action item is the proposed 2026 hearing 17 calendar. Traditionally, the Commission members have 18 set the next year's hearing calendar at the September 19 hearing. 20 While Commission meetings are generally held on the 21 fourth Friday of odd-numbered months, unless they 22 conflict with a holiday, this year, an alternative 23 schedule is proposed with hearings on the second Friday 24 of even-numbered months. 25 So Option A. This is the -- this is our

1	traditional calendar. The Thanksgiving holiday
2	conflicts with the Commission's regular hearing date, so
3	the hearing will be moved to the following Friday. And
4	the May hearing is proposed to be the Friday before
5	Memorial Day weekend.
6	The dates are January 23rd, March 27th, a tentative
7	hearing on April 24th, May 22nd, July 24th,
8	September 25th, a tentative hearing on October 23rd, and
9	December 4th.
10	Option B. This would be the second Friday of
11	even-numbered months. The February hearing is proposed
12	for the Friday before President's Day. And the April
13	hearing is proposed for the Friday after Easter.
14	And the dates are February 13, April 10, a
15	tentative hearing on May 15, June 12, August 14,
16	October 9, a tentative hearing for November 13, and
17	December 11.
18	Staff recommends the Commission adopt one of the
19	proposed 2026 hearing calendars.
20	CHAIRPERSON PERRAULT: Thank you so much.
21	I know you have some additional items to comment
22	on, but let's please take up this action item first.
23	Before I move to conversation amongst the
24	commissioners, are there any is there any public
25	comment on the 2026 hearing calendar?

1	MR. SUPACHANA: Madam Chair, there are no online
2	public comments.
3	MS. GMUR: No comments in the room, Madam Chair.
4	CHAIRPERSON PERRAULT: Okay. Thank you.
5	Then I'm going to go ahead and bring it back to the

14	holidays.
15	Is there a preference or are there comments from
16	commissioners regarding the options?
17	Yes, Ms. Greene Ross.
18	MEMBER GREENE ROSS: I appreciate the additional
19	options
20	(Court reporter interruption.)
21	CHAIRPERSON PERRAULT: We can hear you.
22	MEMBER GREENE ROSS: I'm a big fan of the second
23	option, B. I would prefer not to have some of the
24	holiday weekends that the original one has.
25	CHAIRPERSON PERRAULT: Okay. Excellent.

1	Any other comments from the commissioners?
2	(No response.)
3	CHAIRPERSON PERRAULT: I will just note that I did
4	ask the Executive Director to look at some additional
5	options because it many of the State's boards and
6	commissions tend to like to meet in the last week of
7	each month, which can make it a little bit difficult for
8	some of us who sit on multiple boards when we come up
9	with some conflicts.
10	I appreciate her bringing forward an alternative
11	option.
12	Ms. Greene Ross has indicated her preference would
13	be Option B, which would move us to the second week.
14	Ms. Greene Ross unless there's other comments
15	from commissioners, Ms. Greene Ross, would you like to
16	make a motion?
